



NOTICE OF TERMINATION OF WHOLESALE WATER SERVICE TO THE CITY
OF LIVINGSTON FOR NONPAYMENT OF BILLS

Comes the Wood Creek Water District, by Counsel, and gives notice to the Public Service Commission of the intent of Wood Creek Water District ("Wood Creek") to terminate the wholesale water service to the City of Livingston ("Livingston").

This notice is given in compliance with the Order of the Public Service Commission ("PSC") dated May 25, 2006.


In support of this Notice, Wood Creek states that although Wood Creek and Livingston agreed on May 22 in the presence of the PSC that Livingston would pay \$10,194.88 and remain current in the payment for water services, Livingston has failed to do either. This agreement was recited in the Order of the PSC dated May 25, 2006. Livingston paid \$9,200 on May 26, leaving a deficiency of \$994.88. A bill for water to Livingston from Wood Creek has been mailed to Livingston for an additional \$3,048.71, for a total of \$4,043.59 that is now due and owing.


The failure of Livingston to make payment to Wood Creek is consistent with Livingston's failure to pay in the past. Livingston has a history of failing to make payment to Wood Creek for water for the past three (3) years. The failure of Livingston to make payment to Wood Creek for water is causing a hardship to Wood Creek and the

ultimate effect is that Wood Creek customers are financing and paying for water to Livingston.

When Wood Creek retail customers are delinquent in payment and an agreement is entered into for payment and the customer becomes delinquent again, Wood Creek is allowed to legally terminate service to the retail customer; Wood Creek should not be required to extend greater courtesies and considerations to Livingston than to its own retail customers.

For all of these reasons, Wood Creek hereby gives notice of its intent to terminate water service to the City of Livingston on June 15, 2006.


