

Dear Mr. Wuetcher:

This letter will confirm our discussions of March 13, 2007 wherein you advised that the Public Service Commission had not received pleadings that I filed on behalf of the Henry County Water District #2 in the above-captioned matter. Pursuant to our discussions you advised that if I would forward those pleadings to you, copies of which are enclosed, that you would bring these pleadings to the attention of the Commission and that you did not envision that there would be any problem proceeding to a hearing in this matter. As indicated in the pleadings, I sent them to the Public Service Commission on February 27, 2007 and David Spenard of the Office of the Attorney General indicated that he received same shortly thereafter.

In addition, you asked me to provide you some supplemental information concerning the cost of the legal advertising. Enclosed you will find a copy of an invoice that the Henry County Water District #2 received from the Henry County Local for publication of the notice in the sum of \$199.44. It is my understanding that since the District is located in five (5) counties, publication in each of those county newspapers would have been in a similar amount thus making the cost nearly \$1,000.00 to publish the advertisement. 
