The Commission ordered that the conference be convened to discuss the procedural matters related to the scheduled hearing in this case.

Beginning the conference, Mr. Wuetcher stated that Commission Staff would prepare minutes of the conference for the case record, that a copy of these minutes would be provided to all parties, and that all parties would be given an opportunity to submit written comments upon those minutes.

Mr. Wuetcher stated that the parties were allotted 10 minutes each for opening statements. Mr. Baxter and Mr. Spenard indicated that they wished to make opening statements.
