NOTICE OF FILING

Comes the Applicant, Farmdale Development Corporation ("Farmdale"), by counsel, and pursuant to the direction of the Honorable Howell Brady, Jr., Hearing Officer at the October 26, 2006 Hearing conducted in the above-styled case, hereby files the additional quotes of the cost of the Remote Lift Station (uninstalled) that is the subject of this Application.

- 1) The September 27, 2005 quote provided by Smither Consulting Company reflected that the cost to replace the Remote Lift Station is \$30,425.00, which includes the cost to install same. Attached to the quote of Smither Consulting Company is Kentucky Service Company's quote in the amount of \$15,301.00 provided to Smither Consulting Company for the cost of the Remote Lift Station itself, prior to installation. This quote was attached as Attachment A to the Prefiled Testimony of Carroll Cogan. (See Attachment A).
- 2) The November 22, 2006 quote provided by D & F Distributors, Inc., for the cost of the Remote Lift Station of \$14,140.00, plus freight costs of \$400.00. This quote did not include the cost to install the Remote Lift Station.
- 3) The October 11, 2006 quote provided by Staeffer Pump & Supply, Inc., for the cost of the Remote Lift Station of \$14,890.00, plus freight costs. This quote did not include the cost to install the Remote Lift Station.

Dear Mr. Cogan:

For your information, the following items of repair or replacement need to be considered for the very near future at the referenced facility:

1. The old grating on top of the lift station at the plant is deteriorated to the point that it is unsafe to step on. New grating needs to be installed.

\$1,405.00 Installed

2. The larger plant needs new diffuser drop pipes complete with diffusers. There are fourteen (14) drops in all.

\$4,120.00 Installed

3. The small plant needs to be cleaned, scraped and painted outside and to the water line on the inside.

\$3,050.00

4. The small plant also needs a standby blower motor assembly. If the existing blower, which is quite old, should need repair there would then be nothing to aerate that plant. A new Roots 45 UR4I blower-motor assembly, complete with mounting base, all accessories, duplex control panel and installation would cost

\$9,320.00

5. The existing chlorine contact tank is in very bad condition and needs to be replaced with a new 1700 gallon steel tank.

\$17,225.00 Installed

Note: I would recommend that this be done after the tertiary lagoon is pumped down and cleaned out and before the secondary effluent is routed back into the lagoon.

6. The remote lift station, which consists of a 60" x 10' fiberglass basin, two (2) 5 H.P. 230 volt 3 phase grinder pumps, guide rail assembles and control panel, is also in very bad condition and needs to be completely replaced.

\$30,425.00

Note: This price includes taking down the fence, removing trees, excavating around the existing station, furnishing the new fiberglass basin, pumps, control panel, taking out the old station, installing the new, making external piping connections, electric connections, back fill, finish grade, and reinstall the fence. Does not include tank truck expense to haul sewage away while station is out of service.

The above pricing is good to the end of 2005. After that some increase may be necessary. Steel prices keep going up and the supplier of the lift station will probably have an increase of about 3 to 4% after the first of the year.

No sales tax has been included.

- Two (2) -Myers WG50H-23-25 grinder pumps, with 25' of power and control cord; double mechanical carbon/ceramic scals with seal leak feature; heat sensor on motor winding; and driven by a 5 H.P., 3450 RPM, 3/230 volt oil filled submersible motor.
- One (1) -Myers Basin package, 60 " x 120" fiberglass basin with: anti-floatation collar; RWGB rail system with lift out check valve and all items necessary for guide rail removal of pumps. Basin to include 2"brass shutoff valves with extension handles, stainless steel rail pipe, stainless steel lifting cable, stainless steel float bracket, aluminum hinged cover with 2" mushroom vent, and 2" PVC schedule 80 discharge pipe module (single 2" line exits the basin). Basin to include a junction box where all float and pump cords will be landed.
- 4" inlet grounnet to be field installed by others on the basin at the desired One (1) location.
- Four (4) -Float switches with stabilizing weight.

- 1. We EXCLUDE the following equipment: startup services (see note 3); freight; installation, electrical conduit and wire; nothing on service pole; spare parts; and pressure gauges.
- 2. Estimated delivery on this equipment, 4-6 weeks after receipt of approved shop drawings. Please allow 2-4 weeks for shop drawing completion if required.
- 3 Start-up services are excluded in the quoted price. If start-up services are required, please add \$500. per trip. Please notify our service department 2-3 weeks before startup event to schedule.
- 4. The design conditions are missing. We have quoted a pump model whose performance is closest to Ebara model given to us.
- 5. Concrete required to properly anchor the basin (to prevent flotation) is excluded. The pumps will NOT ship inside the basin to prevent damage. Thus, these need to be installed in the filed. Likewise, the floats are not hung on the float bracket and will need to be field installed.
- 6. MYERS published 5 year prorated warranty applies.
- 7. VALUE ADDED CONSIDERATIONS: Note that we include a hinged aluminum cover which is non corresive whereas our competition has quoted steel which is corresive. We also include stainless steel guide rail pipes. Our competition did not indicate the alloy of their guide rail pipes. Finally, our pumps carry a 5 year prorated warranty versus Ebara one year,

Our terms with approved credit are net 30 days with 1.5% interest per month added to past due accounts, as well as all costs and expenses incurred in collecting any amounts due, including reasonable attorney's and collection fees. We also accept, for your convenience, MasterCard, Visa, Discover, and American Express credit cards.

All taxes are excluded from our prices and must be added if applicable. Our price is protected for 30 days from the quote date. If a letter of intent is issued during the 30 days, we will hold our prices for an additional 45 days.
