

**JOINT STATUS REPORT OF THE PARTIES**

In its Order dated July 17, 2009, the Kentucky Public Service Commission ("Commission") required the parties to this proceeding to submit to the Commission written

reports on the status of settlement negotiations. AT&T Mobility<sup>1</sup>, Sprint PCS<sup>2</sup>, T-Mobile<sup>3</sup> and Verizon Wireless<sup>4</sup> ("CMRS Providers") and the RLECs<sup>5</sup> hereby jointly notify the Commission that the CMRS Providers and the RLECs are engaged in good faith negotiations and are continuing these negotiations in an effort to resolve the issues in this case. The Parties will provide an updated status of these negotiations in the upcoming Informal Conference scheduled for August 6, 2009.




