## <u>ORDER</u>

This matter is now before the Commission upon instruction of the United States District Court for the Eastern District of Kentucky, pursuant to its May 20, 2009 Memorandum Opinion and Order and Judgment,<sup>1</sup> remanding Issue 2 back to the Commission for the purpose of providing "factual support for its determination and/or choice of DS1 (or some other level of traffic) as the threshold level requiring a dedicated

trunk line."<sup>2</sup> The Court also instructed the Commission to direct the commercial mobile radio service providers ("CMRS Providers")<sup>3</sup> and rural local exchange carriers ("RLECs")<sup>4</sup> to submit "new conformed interconnect agreements consistent with [the Court's] Memorandum Opinion and Order."<sup>5</sup> The Court ordered that the Commission "shall approve all such new conformed interconnection agreements consistent with the Court's Memorandum Opinion and Order."<sup>6</sup>

The Commission finds that, in furtherance of the Court's instructions on the remand of Issue 2 and the instructions on the submission of new interconnection agreements from the parties, an informal conference shall be held to discuss the next procedural steps for these proceedings, including establishing a procedural schedule centered on Issue 2. The informal conference will be held on July 2, 2009 at 2:00 p.m.,
