807 KAR 5:063: Section 1(1)(n) 1. A statement that the local county judge, executive, has been: Notified by certified mail, return receipt requested, of the proposed construction;

807 KAR 5:063: Section 1(1)(n) 2. A statement that the local county judge, executive, has been: Given the Commission docket number under which the application will be processed; and

807 KAR 5:063: Section 1(1)(n) 3. A statement that the local county judge, executive, has been: Informed of his right to request intervention.

807 KAR 5:063: Section 1(1)(o) A copy of the notice sent to the county judge executive.

The statutory time period in which the Commission must process this case will not commence until the above-mentioned information is filed with the Commission. If your filing contains a proposed effective date, the rejection of your filing for reasons of deficiencies voids that proposed effective date. When you file the required information to correct the deficiencies, you may refile your proposed tariff with a new proposed effective date that is at least 30 days from the date you file the required information.
