The petition of Owen Electric Cooperative, Inc., respectfully shows:

- (A) That the Applicant is engaged in the business of distributing and furnishing electric current to approximately 54,923 member-consumers in North-Central Kentucky, in the Counties of Owen, Grant, Pendleton, Gallatin, Scott, Boone, Kenton, Campbell, and Carroll.
- **(B)** The post office address of Applicant is PO Box 400, Owenton, Kentucky, 40359-0400
- (C) That a copy of the Applicant's Articles of Incorporation are on file with the Commission as part of Case No. 90-166, filed June 13, 1990, amendments to Articles as part of Case No. 92-064, filed in February 18, 1992, and amendments to Articles filed with the State of Kentucky on July 14, 2005 per Exhibit 6 attached.
- (D) That the Applicant's property consists of its headquarters office building, service center, and storage yards in Owenton, Kentucky; a branch office building in Butler, Kentucky; a service center and storage yards in Walton, Kentucky; and approximately 4,961 miles of distribution line and other related equipment and property in which there has been invested a total \$164,449,242 as of April 30, 2006, which is considered Owen Electric's utility plant. The net value of said plant after accumulated depreciation and amortization as of said date was \$112,741,347.
- That Applicant proposes to install Automated Meter Reading System as an addition to its **(E)** existing plant.
- (F) That Applicant anticipates financing the additions through a long-term RUS/FFB loan.

- (G) That the estimated cost of operation of the proposed facilities after completion will be \$1,239,915 annually.

## AMENDMENT OF ARTICLES OF INCORPORATION OF OWEN ELECTRIC COOPERATIVE, INC.

### KNOW ALL MEN BY THESE PRESENTS:

That we, Robert M. Marshall, President, and Stanley Gosney, Secretary of Owen Electric Cooperative, Inc., (hereinafter called the "Corporation") do hereby certify:

That at a meeting of the Directors of the Corporation duly held on the 27<sup>th</sup> day of January, 2005, in conformity with the constitution and laws of the Commonwealth of Kentucky, it was unanimously resolved that the amendments of the Articles of Incorporation of the Corporation hereinafter set forth be approved and recommended to the members for approval.

Further, at a meeting of the members of the Corporation duly held on the 24<sup>th</sup> day of June, 2005, in conformity with the constitution and laws of the Commonwealth of Kentucky, the following amendments of the Articles of Incorporation of the Corporation were adopted by a majority of the votes entitled to be cast by the members present in person and voting at said meeting:

1. Section 2 of Article VIII of the Articles of Incorporation shall be amended to read as follows:

Section 2. Any natural person, firm, association, corporation, body politic or subdivision thereof shall become a member of Owen Electric Cooperative, Inc., upon the occurrence of either of the following:

- (a) Signing of an application for membership in Owen Electric Cooperative, Inc.,
   and payment of the other deposits and fees specified in the bylaws; or
- (b) Payment of the first bill received from Owen Electric Cooperative, Inc., for electric energy and payment of the other deposits and fees specified in the bylaws.

No natural person, firm, association, corporation, body politic, or subdivision thereof may own more than one (1) membership in the Cooperative.

A husband and wife may jointly become a member of the Cooperative as specified in the bylaws.
