We are homeowners along Grandview Rd. and Amy Lou Dr. in Campbell Co. near Alexandria KY. We have been trying to get public water service for our homes for a very long time, some as long as 35 years.

Finally, we are getting a water line down our roads! We were told by the Northern KY Water District we would be assessed a surcharge of about \$30 a month to help pay for it.

Many of us signed up for that. Now we are told the KY Public Service Commission doesn't want the cost to be paid this way. Instead, we would have to pay a large amount (\$4,000. to \$6,000. or more) up front when we hook into the service. This is besides the connection fee of \$750.

That will cause most all of us to back out or at least re-consider. Especially if, as we have heard, we wait for about 5 years to connect we wouldn't have to pay that fee. If that happens, how WILL it be paid for then?

Shouldn't a more fair way to pay for this be by the surcharge so that whoever lives in the homes in the next years help pay for the service instead of just those who happen to live there now?

We ask you as the Executive Director and all of the Commission to reconsider your position on this and let us go with the surcharge. Many before us have done it this way and we ask to be allowed the same consideration.
