## ORDER

On March 2, 2009, Community Action Kentucky, Inc. ("CAK") filed a motion for an extension of time, from February 28, 2009 to March 31, 2009, to file an assessment and evaluation of a Home Energy Assistance ("HEA") program implemented in 2007 by Kentucky Power Company ("Kentucky Power"). CAK states that it is unable to complete the assessment and evaluation of the HEA program by February 28, 2009 as agreed upon due to other commitments relating to the implementation of a statewide Low Income Home Energy Assistance Program.

Based on the motion and being otherwise sufficiently advised, the Commission finds that the programmatic details of Kentucky Power's HEA program were approved by Commission Order dated December 14, 2006 in Case No. 2006-00373. One of the provisions of the HEA program was that Kentucky Power and CAK would jointly file, by

February 28, 2009, an assessment and evaluation, including a quantification of cost savings, of the first two years' operations of the HEA program. Finding good cause for the request for a one-month extension of time, the Commission will grant CAK's motion. The Commission further finds that the HEA program as approved provides that the assessment and evaluation are to be filed jointly by Kentucky Power and CAK. Consequently, the filing of that assessment and evaluation, or any subsequent motions related thereto, should include Kentucky Power as a joint or sole applicant or movant, as appropriate. In addition, CAK's motion will be placed in Case No. 2009-00117, and all future filings relating to the assessment and evaluation should be made in that case only.

## IT IS THEREFORE ORDERED that:

- 1. Kentucky Power shall individually or jointly with CAK file the assessment and evaluation of Kentucky Power's HEA program by March 31, 2009.
- 2. Any subsequent motions relating to Kentucky Power's filing obligations shall include Kentucky Power as a movant.
- 3. CAK's motion for an extension of time and all subsequent filings relating to the assessment and evaluation of Kentucky Power's HEA program shall be filed in Case No. 2009-00117.
