- Q-1. Please state whether the Company has sufficient space at existing facilities to accommodate the employees presently working in the Waterside Station who will be moved to other Company offices following disposition of that facility.
- A-1. The Company does have sufficient space at existing facilities to accommodate the employees presently working in the Waterside Station who will be moved to other Company offices following disposition of the real estate at the Waterside Station. There are currently 36 employees that work at the Waterside Facility. The ten employees in Substation Operations will relocate to the South Service Center. The five employees in IT Security and two employees in Transmission will relocate to the E.ON U.S. Center. The remaining 19 employees in the Transmission area will relocate to the new Transmission Dispatch Facility.

- Q-2. In a data response filed on September 12, LG&E indicated that the definite agreement with the Arena Authority would be reached within the next few weeks. Please provide an update on the status of the definitive agreements.
- A-2. A draft of the Relocation Project definitive agreement was provided to the Arena Authority on September 25, 2006. The Company anticipates providing a draft of the Real Property definitive agreement to the Arena Authority by September 29, 2006. LG&E remains unaware of any material outstanding issues which would delay the completion of both definitive agreements. LG&E anticipates executing the definitive agreements by the end of October. There are no contingencies that must be satisfied or events that must occur prior to the finalization of the definitive agreements.
