The Commission entered the enclosed Final O der in this case on November 1, 2006. It was ordered that "NKWD shall file a copy of the "as-built" drawings and a certified statement that the construction has been satisfactorily completed in accordance with the contract plans and specifications within 60 days of the substantial completion of the construction certificated herein.

Also that "NKWD shall furnish documentation of the total costs of this project including the cost of construction and all other capita ized costs (engineering, legal, administrative, etc.) within 60 days of the date that construction is substantially completed. Construction costs shall be classified into appropriate plant accounts in accordance with the Uniform System of Accounts for water utilities prescribed by the Commission."
