ORDER

The city of Wilmore, Kentucky ("Wilmore") has moved for an informal conference in this matter and for additional time in which to respond to the Commission's Order of September 22, 2006. Recognizing that Wilmore has not previously appeared before this Commission, that most of its operations fall outside this Commission's jurisdiction and that it may lack familiarity with this Commission's procedures, the Commission finds that the motions should be granted.

IT IS THEREFORE ORDERED that:

1. Wilmore's motions are granted.
2. An informal conference shall be held in this matter on October 31, 2006, beginning at 1:30 p.m., Eastern Standard Time, in Conference Room 2, of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, for the purpose of discussing the events that gave rise to the Commission's Order of September 22, 2006, the Commission's procedures, and any other issues that may simplify or resolve this proceeding.
3. Wilmore shall have until November 20, 2006 to file its response to the Commission's Order of September 22, 2006.
