<u>O R D E R</u>

On December 21, 1999, in Case No. 1999-00070,¹ the Commission approved rates for Atmos Energy Corporation ("Atmos") and provided for their further adjustment in accordance with Atmos's gas cost adjustment ("GCA") clause.

On September 29, 2006, Atmos filed its proposed GCA to be effective November 1, 2006.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Atmos's notice includes revised rates designed to pass on to its sales customers its expected change in wholesale gas costs.

2. Atmos's expected gas cost ("EGC") for firm sales customers is \$9.1112 per Mcf, an increase of 25.65 cents per Mcf from the previous EGC of \$8.8547. Atmos's EGC for both high load factor ("HLF") firm customers and interruptible sales customers is \$8.2379 per Mcf, an increase of 25.65 cents per Mcf from the previous EGC of \$7.9814.

3. Atmos's notice sets out a current period refund factor ("RF") of (5.54) cents per Mcf for firm sales and HLF firm customers. The total refund factor is (5.54) cents per Mcf for firm sales and HLF firm customers, and (5.54) cents per Mcf for interruptible sales customers, and represents a decrease of 5.37 cents per Mcf from the prior refund adjustment. Atmos's notice sets out no refund adjustment for T-2 firm transportation customers or for T-2 interruptible transportation customers.

4. Atmos's notice sets out a correction factor ("CF") of (30.88) cents per Mcf, which is a decrease of 13.39 cents per Mcf from the previous CF.

5. Atmos's notice sets out a Performance Based Rate Recovery Factor ("PBRF") of 3.99 cents per Mcf, which is effective from February 1, 2006 until February 1, 2007.

6. Atmos's gas cost adjustments are \$8.7869 per Mcf for firm sales customers and \$7.9136 per Mcf for HLF firm customers and for interruptible sales customers. The impact on firm sales customers is an increase of 6.89 cents per Mcf from the previous gas cost adjustment of \$8.7180. The impact on HLF firm customers is an increase of 6.89 cents per Mcf from the previous gas cost adjustment of \$7.8447, and the impact on interruptible sales customers is an increase of 6.89 cents per Mcf from the previous gas cost adjustment of \$7.8447.

7. The rates in the Appendix, attached hereto and incorporated herein, are fair, just and reasonable, and should be approved for final meter readings by Atmos on and after November 1, 2006.


