JOINT MOTION FOR EXTENSION OF TIME


South Central Telcom LLC ("South Central"), and BellSouth Telecommunications, Inc. d/b/a AT&T Kentucky ("AT&T Kentucky") (jointly, the "Parties"), by counsel, hereby jointly move the Public Service Commission of the Commonwealth of Kentucky (the "Commission") for a brief extension of time within which the parties may file their direct testimony and rebuttal testimony in this matter. Pursuant to the Commission's order dated May 21, 2008, the Parties have until Thursday, July 10, 2008 to file their direct testimony and until Monday, July 21, 2008 to file their rebuttal testimony. The Parties move that the Thursday, July 10, 2008 deadline to file direct testimony be extended to **Friday, July 18, 2008**. In addition, the Parties move that the Monday, July 21, 2008 deadline to file rebuttal testimony be extended to **Friday, August 15, 2008**.

As grounds for this motion, the Parties state that this brief extension will provide the Parties additional time to review the recently received responses to data requests and supplemental data requests and draft testimony that will appropriately frame the issues in this matter.

The Parties further state that this motion is not made for purposes of delay and that the requested continuance will not prejudice either South Central or AT&T Kentucky.

Therefore, the Parties request that their joint motion be granted and the Commission extend the deadline to file **direct testimony from Thursday, July 10, 2008 to Friday, July 18, 2008** and the deadline to file **rebuttal testimony from Monday July 21, 2008 to Friday, August 15, 2008.**


