**SUBJECT:** July 2, 2007 Informal Conference

Pursuant to the request of Atmos Energy Corporation ("Atmos") and the Attorney General's Office ("AG"), an informal conference was held on July 2, 2007. Attached to this memorandum as Attachment 1 is a list of the participants. The purpose of the conference was to discuss the Joint Settlement Stipulation and Recommendation ("Joint Settlement") filed by the parties on June 29, 2007.

At the beginning of the conference, the Team explained that since the parties had submitted the Joint Settlement, the Team would not be commenting on the Joint Settlement. Instead, the Team would be identifying issues that needed to be addressed in written testimony supporting the Joint Settlement and could be the subject of questions at the July 10, 2007 hearing.

The Joint Settlement, as filed on June 29, 2007, did not include schedules that were referenced in the document. Atmos and the AG had copies of these schedules at the conference and filed these into the record. The additional information addressed many of the issues the Team had identified. A brief discussion covered any remaining issues, which Atmos agreed would be covered in its testimony. Atmos indicated it believed it would be able to file written testimony in support of the Joint Settlement no later than the morning of July 9, 2007.
