O R D E R

On June 12, 2007, Nolin Rural Electric Cooperative Corporation ("Nolin") filed a motion seeking an extension of time to respond to the data requests previously issued in this case. Pursuant to the revised procedural schedule issued on May 15, 2007, the responses to the outstanding requests are due on June 19, 2007. Nolin requests that it be permitted an additional 10 days, or until June 29, 2007, to respond to these requests. In support of its motion, Nolin cites the numerous matters addressed in the requests and states that it requires "further research and will be quite time consuming." In addition, it states that two of Nolin's responding witnesses have not been available due to other obligations.

The Commission finds Nolin has provided good cause to support its request for additional time to respond. However, granting Nolin's requested extension will require that other dates in the May 15, 2007 revised procedural schedule be changed. The Commission hereby amends the procedural schedule of May 15, 2007 and adopts the schedule included in Appendix A, attached hereto and incorporated herein.

IT IS THEREFORE ORDERED that the procedural set forth in Appendix A shall be followed in this case.
