RESPONSE OF ACORN TELEPHONE, LLC

Acorn Telephone, LLC ("Acorn"), for its response to the Commission's order dated December 4, 2006 in the captioned proceeding, responds as follows.

The Commission's Order requires Acorn to show cause why it should not be penalized for failing to file a gross operating report for 2005. As shown in the attached Exhibit, Acorn timely filed a report for 2005 and should not be penalized.

Acorn is registered in Kentucky as both a CLEC (Utility ID 22251718) and an IXC (Utility ID 5171800). On or about March 30, 2006 Acorn filed a combined gross operating revenue report which included all assessable revenues for local and toll services provided in Kentucky. Acorn also filed a single annual report which referenced interLATA minutes of use as well as information about local lines in service.

Insofar as all assessable revenues were included in the combined gross operating revenue report, Acorn is in compliance with KRS 278.140. Acorn respectfully requests that the Commission issue an order finding that Acorn is in compliance and dismissing Acorn as a party to this investigation.
