SUPPLEMENTAL DATA REQUEST OF COMMISSION STAFF
TO EAST KENTUCKY POWER COOPERATIVE, INC.

East Kentucky Power Cooperative, Inc. ("East Kentucky") is requested, pursuant to 807 KAR 5:001, to file with the Commission the original and 3 copies of the following information, with a copy to all parties of record. The information requested herein is due no later than 21 days from the date of issuance of this request. Each copy of the data requested should be placed in a bound volume with each item tabbed. Responses to requests for information shall be appropriately indexed, for example, Item 1(a), Sheet 2 of 6, and shall include the name of the witness responsible for responding to the questions related to the information provided. Careful attention shall be given to copied material to ensure its legibility.

Each response shall be under oath or, for representatives of a public or private corporation, a partnership, an association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

East Kentucky shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though

correct when made, is now incorrect in any material respect. For any request to which East Kentucky fails to furnish all or part of the requested information, East Kentucky shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be provided for total company operations and jurisdictional operations, separately.

1. On April 11, 2007 East Kentucky filed its revised tariffs reflecting the interim rate increase authorized by the Commission's Order in Case No. 2006-00472¹ dated April 1, 2007. Based upon the interim rates approved by the Commission's April 1, 2007 Order and reflecting East Kentucky's proposed \$.00613 per kWh FAC roll-in, provide:

a. A schedule of the present (interim) rates and revised rates reflecting the FAC roll-in, shown in a comparative form.

b. Revised tariffs which cross-out present (interim) rates and insert the revised rates which include the proposed FAC roll-in.
