O R D E R

On October 12, 2007, the Commission entered an Order approving the transfer of additional fuel costs from Kentucky Utilities Company's ("KU") fuel adjustment clause ("FAC") into its base rates. Ordering paragraphs 3 and 4, however, incorrectly stated:

3. The rates in Appendix A are approved to be effective with KU's first billing cycle for November 2007. (Emphasis added.)
4. Beginning with its first billing cycle for November 2007, KU shall use an FAC rate based on a base fuel cost of 25.91 mils per kWh. (Emphasis added.)

The underlined word "November" in ordering paragraphs 3 and 4 was incorrect and should have read "December."


