O R D E R

This matter is before the Commission on its own motion. In light of an August 1, 2007 Opinion and Order entered by the Franklin Circuit Court in the matter of *Commonwealth of Kentucky, ex rel. Gregory D. Stumbo, Attorney General, v. Public Service Commission and Union Light, Heat and Power Company*, Civil Action 06-CI-269, the parties are requested to brief whether the relief sought by Louisville Gas and Electric Company ("LG&E") is lawful.

Accordingly, IT IS HEREBY ORDERED that:

1. The Intervenors shall file with the Commission a Memorandum of Law regarding the lawfulness of the relief sought by LG&E in this matter no later than 5:00 p.m., Eastern Daylight Time, on August 24, 2007, and shall serve by electronic mail a copy of said Memorandum of Law on counsel for LG&E.

2. LG&E shall file with the Commission a responsive Memorandum of Law regarding the lawfulness of the relief it seeks in this matter no later than 5:00 p.m. on August 29, 2007, and shall serve by electronic mail a copy of said Memorandum of Law on the Intervenors.
