**MOTION OF LOUISVILLE GAS AND ELECTRIC COMPANY  
TO MODIFY PROCEDURAL SCHEDULE**

Louisville Gas and Electric Company (“LG&E”) hereby moves the Public Service Commission (“Commission”) to modify the procedural schedule in this proceeding in the manner set out below to afford LG&E the opportunity to issue data requests concerning, and rebuttal testimony to, the testimony that Intervenor Kentucky Industrial Utility Customers, Inc. (“KIUC”), has stated it will file in this proceeding. Allowing time for additional discovery and rebuttal testimony will also require rescheduling the hearing date in this proceeding, currently scheduled for March 14, 2007. The requested modification is necessary because KIUC has stated it intends to file testimony by March 9, after the last day for LG&E to file the required hearing notice. Keeping the current procedural schedule while allowing KIUC to file testimony as late as March 9 would effectively preclude LG&E from having the opportunity to have discovery of the testimony or rebut it if LG&E determines to do so. Therefore, LG&E respectfully moves the Commission to modify the procedural schedule of this proceeding as follows (regular type indicates dates already in the procedural schedule that LG&E does not propose to change; italic type indicates new or changed dates):


Thursday, February 8, 2007	Data requests to LG&E are due
Friday, February 23, 2007	Data responses of LG&E are due

<i>Friday, March 9, 2007</i>	<i>Intervenor testimony is due</i>
<i>Thursday, March 22, 2007</i>	<i>Data requests to Intervenors are due</i>
<i>Friday, April 6, 2007</i>	<i>Intervenor data responses are due</i>
<i>Thursday, April 19, 2007</i>	<i>Rebuttal testimony by LG&amp;E is due; last day for LG&amp;E to publish notice of hearing</i>
<i>Thursday, April 26, 2007</i>	<i>Hearing at the Commission</i>

**WHEREFORE**, LG&E respectfully moves the Commission to enter an order modifying the procedural schedule in this proceeding as set out above to afford LG&E the opportunity to issue data requests concerning, and rebuttal testimony to, the testimony that KIUC has stated it will file in this proceeding.
