SUBJECT: Informal Conference

Pursuant to Staff Notice, an informal conference ("IC") was held on May 31, 2007, at the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky 40602. A copy of the conference attendance list is attached. By motion dated May 23, 2007, Louisville Gas & Electric Company and Kentucky Utilities Company (collectively the "Companies") requested that the Commission schedule the IC to address a question raised by Commission Staff during the May 10, 2007, hearing concerning reconciliation of Midwest Independent Transmission System Operator, Inc. ("MISO") costs and revenues. In addition, pursuant to its notice, Staff asked that the Companies be prepared to discuss revenues and costs resulting from certain MISO transactions that were charged or credited to Account 151 of the FERC Uniform System of Accounts for Public Utilities and Licensees.

The Companies began the IC with a brief statement about their concerns over any negative inference that may have been left by the Companies' answer to the hearing question. The Companies then offered to answer any questions that Commission Staff, or intervenors had concerning the Companies' answer at the hearing, or the Companies' position on the treatment of MISO costs and revenues. The Companies also agreed to furnish in writing, their response to Staff's question concerning the accounting treatment of MISO costs. The written response is due on, or before, submission of briefs.

The IC was then adjourned.
