This is an application to revise language and certain non-recurring charges for the Union County Water District. Attached is the non-recurring charge cost justifications and the proposed new tariff.




RE: Formal Application for Tariff Revisions



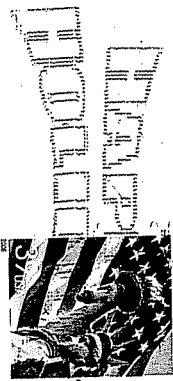
