Dear Ms. O'Donnell:

Please find attached the original and one copy of the documents requested by the Commission Staff during the Informal Conference held in the above referenced matter on May 15, 2007. These documents reflect the following:

- 1) The Hardin County Water District ("Hardin County") issues the bills for Airview Utilities and also collects the customer payments for Airview Utilities. The monthly rate is billed separately from the monthly surcharge, and Airview Utilities receives a check containing the payment from Hardin County for the monthly rate and then a second check for the payment on the monthly surcharge. The records reflect that the bills for the surcharge are issued by Hardin County in one month and the following month the surcharge payments are received by Airview Utilities. For example, the amount billed for the surcharge in July, 2004 was \$3,410.07 and Airview received a payment of \$3,157.73 on September 17, 2004.
- 2) The amounts billed by Hardin County each month vary, apparently because the number of customers varies in this somewhat transient neighborhood. The records reflect that the surcharge collections received each month were immediately deposited into the surcharge account.



- 3) The amount collected for each month did not always equal or exceed \$3,306.21, but it is projected that the total amount of the surcharge collected, including the receipts for the June 2007 billing will be \$117,755.65. The Commission authorized a total surcharge of \$118,990.00. Airview Utilities plans to make up any shortfall in surcharge collections that may occur out of its rate collections.

Please note that an original of these documents has been filed with the Commission in order to comply with the request of Commission Staff made at the May 15, 2007 Informal Conference. Please notify me if Airview Utilities is required to provide an additional ten (10) copies, which is the case for responses to discovery requests pursuant to Commission regulations, and the additional copies will be provided.
