MOTION OF EXTENSION OF TIME

Come Airview Utilities, LLC, Martin Cogan and Larry Smither (the "Respondents"), in their individual and official capacities and for their Motion for Extension of Time, state as follows:

1. On December 22, 2006, the Public Service Commission ("Commission") entered an Order in the above-styled action requiring a written response within 20 days of the date of the Order. Airview Utilities, LLC, Martin Cogan and Larry Smither did not receive the copy of this Order. Furthermore, the Respondents had no notice of the Order until Robert Cowan, counsel for the Commission, advised Robert Moore, counsel for the Respondents, on or about Monday, January 22, 2007 that such an Order had been issued.


2. On or about Monday, January 22, 2007, while out of the office on vacation, Mr. Moore contacted Mr. Cowan concerning the status of an unrelated case pending before the Commission. At the close of the conversation concerning the unrelated case, Mr. Cowan asked Mr. Moore whether he represented Airview Utilities, LLC and whether an answer had been filed to the Commission's December 22, 2006 Order to Show Cause. Mr. Moore requested Mr. Cowan to review the record and confirm that an Order had been issued regarding this matter, because he was unaware of same, and Mr. Cowan agreed to do so.

3. On Thursday, January 25, 2007, Mr. Moore returned to his office and contacted Mr. Cowan concerning the subject Order. At that time, Mr. Cowan advised Mr. Moore that a Show Cause Order had been issued by the Commission on December 22, 2006, and provided Mr. Moore with the case number so that the Order could be obtained from the Commission's website.

4. On January 25, 2007, Mr. Moore obtained a copy of the subject Order and forwarded it to Airview Utilities, LLC and Martin Cogan and Larry Smither by facsimile. Accordingly, the Respondents' counsel first became aware of the Show Cause Order on January 25, 2007.

5. The December 22, 2006 Show Cause Order requires the Respondents to file its response within 20 days of the date of the Order. Accordingly, the Respondents hereby request that they be granted 20 days from January 25, 2007, within which to respond to the Commission's December 22, 2006 Show Cause Order.
