
COMMISSION STAFF'S NOTICE TO CANCEL

On June 5, 2008, the Complainants and the Defendant moved, jointly, to cancel and reschedule the informal conference set to occur on June 10, 2008.

The parties state that they have held numerous discussions seeking to identify the relevant technical and legal issues in this case. The parties also state that they have had some success in identifying the issues and potential solutions. The parties contend that they will require an additional 2 to 3 weeks to continue those discussions and, hopefully, simplify and reduce the issues in question.

Commission Staff has no objection to the request. The informal conference originally scheduled to be held on June 10, 2008 at 2:00 p.m., Eastern Daylight Time, is cancelled.
