O R D E R

On November 7, 2007, the Commission convened a hearing in this proceeding to take evidence and permit cross-examination on the reasonableness of the Joint Settlement, Stipulation and Recommendation entered into by the parties on November 1, 2007. At the hearing Fleming-Mason Energy Cooperative Corporation, Inc. ("Fleming-Mason") provided proof of its publication of the notice of hearing in the *Kentucky Living* magazine. The Commission, having reviewed the notice and considered the parties' respective arguments, found that the notice did not strictly comply with the statutes and regulations governing notice and ordered that the hearing be continued to permit proper notice.

IT IS THEREFORE ORDERED that:

1. The public hearing in this matter shall resume at 9:00 a.m., Eastern Standard Time, on November 28, 2007 in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.
2. Fleming-Mason shall notify its customers in writing of the date, time, place, and purpose of the hearing or shall publish notice in accordance with 807 KAR 5:011,


Section 8(5), in the newspapers of general circulation in each of the counties affected by the proposed rate increase.

3. Fleming-Mason shall file an Affidavit of Publication of Hearing Notice with the Commission on the day of the hearing.
