COMMISSION STAFF'S SUPPLEMENTAL DATA REQUEST
TO MIKE LITTLE GAS COMPANY, INC.

Mike Little Gas Company, Inc. ("Mike Little"), pursuant to 807 KAR 5:001, is to file with the Commission the original and 3 copies of the following information, with a copy to all parties of record. The information requested herein is due on or before December 14, 2007. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Mike Little shall make timely amendment to any prior responses if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any requests to which

Mike Little fails or refuses to furnish all or part of the requested information, Mike Little shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations.

1. In its response to the Commission's Order, Mike Little submitted a letter from the Kentucky Department of Transportation advising Mike Little as to the construction of its gas line on a state right-of-way.

a. State whether Mike Little has applied to the Kentucky Department of Transportation for an encroachment permit to construct a gas main on a state right-of-way. If yes, state the date of the application and its current status.

b. List and describe each meeting or conversation that Mike Little's representatives have had with representatives of the Kentucky Department of Transportation regarding the construction of the gas main.

c. State when Mike Little expects to complete construction of the gas line if it cannot obtain the required permits.
