On February 15, 2008, a telephonic conference was held with Commission Staff and Mike Little Gas Company, Inc. ("Mike Little") Those participating by phone were: Miki Thompson, President of Mike Little, and Kara Vance, certified operator, Jason Brangers, and J. R. Goff.

Miki Thompson stated that all steel pipe replacement had been accomplished except for the section that is the subject of the encroachment permit issue with the Kentucky Department of Transportation. She indicated that she was attempting to meet with the district engineer to obtain a permit, but, failing that, the other options were to seek right-of-way from other sources or file an action in circuit court.

Ms. Thompson agreed to file a status report with the Commission.
