West Virginia PCS Alliance LC d/b/a NTELOS moves the Public Service Commission of Kentucky for an Order extending to May 25, 2007 the date for responding to the letter of Joseph Hessami. In support thereof, NTELOS states:

1. By letter dated April 24, 2007, Joseph Hessami expressed certain concerns to the Commission regarding NTELOS' application and proposal to erect a communications tower of Donta Road.

2. The Commission, by letter from its Executive Director, directed NTELOS to address Mr. Hessami's concerns in writing within fifteen days of April 27, 2007. Unless the extension requested herein is granted the response will be due on May 14, 2007.

3. Neither NTELOS or its counsel received a copy of either Mr. Hessami's letter or the April 27, 2007 letter of the Commission's Executive Director. Nor were NTELOS or its counsel aware of either letter prior to May 10, 2007.


4. On May 10, 2007 counsel for NTELOS was reviewing filings in this case in connection with the Commission's May 9, 2007 Order. Only then did counsel for NTELOS become aware of the Executive Director's April 27, 2007 Order and Mr. Hessami's earlier letter.

5. NTELOS wishes to respond to Mr. Hessami's April 24, 2007 letter in as complete fashion as possible but, having learned of the letter and the Executive Director's April 27, 2007 letter only yesterday, can not do so by the deadline.

6. The requested extension is not made for purposes of delay and will not prejudice Mr. Hessami or the Commission.

Wherefore, West Virginia PCS Alliance LC d/b/a NTELOS moves the Public Service Commission of Kentucky for an Order extending to May 25, 2007 the date for responding to the letter of Joseph Hessami.


