Pursuant to Commission Staff's request, an informal conference was held on October 19, 2007. Attached hereto are the names of those that participated in the informal conference.

Beginning the conference, Commission Staff stated that it would prepare minutes of the conference for the case record, that a copy of these minutes would be provided to all parties, and that all parties would be given an opportunity to submit written comments upon those minutes.

The following is a brief description of the issues that were discussed at the informal conference:

- The outstanding procedural matters in Case No. 2006-00315, Sub-district F proceeding, and the need for a hearing.
- NKWD explained that its response in Case No. 2007-00398<sup>1</sup> had been drafted and a copy had been sent to the AG's office. NKWD is waiting for the AG's comments before submitting the revised depreciation study to the Commission.
- The AG stated that based upon their expert's preliminary review of NKWD's depreciation study, they have some concerns with the study. In the AG's view NKWD should request the Commission to reconsider its finding that the main rehabilitation costs should be expensed rather than capitalized. This would eliminate the potential problem NKWD could have

if it attempts to use bond proceeds to fund the main rehabilitation projects. NKWD stated that this issue was not raised in this current proceeding and that funding the main rehabilitation with bond proceeds is currently not a problem.

 Commission Staff discussed their proposed adjustments to the revenue requirement contained in NKWD's Application. NKWD stated that Commission Staff's proposed adjustments are acceptable and agreed to revise its revenue requirement schedule in the application in Case No. 2007-00135 to reflect Commission Staff's adjustments. The AG stated that they would not object to NKWD's revision.

The informal conference was adjourned for lunch at 11:45 a.m. at which time Mr. Spenard and Mr. Hughes stated that they would not return for the discussion of Case No. 2006-00315, the surcharge for Sub-district F.

When the informal conference reconvened, NKWD explained the process it uses to select the areas that will be served in a sub-district. They also discussed the reason for the \$30 cap on the sub-district surcharges and what costs they recover through the surcharge proceeds. Commission Staff requested NKWD to file additional evidence to sufficiently explain their procedure for selecting and funding the sub-districts by use of a surcharge.
