**PETITION TO INTERVENE OF
ALCAN ALUMINUM AND
CENTURY ALUMINUM**

Pursuant to K.R.S. §278.310 and 807 KAR 5:001 Section 3(8), Alcan Primary Products Corporation and Century Aluminum of Kentucky, LLC (“Alcan/Century”) request that they be granted full intervenor status in the above-captioned proceeding and state in support thereof as follows:

1. Alcan/Century are by far the biggest power consumers in Kentucky. They have a combined demand of approximately 850 MW and consume more than seven billion kWh annually. Alcan/Century are retail ratepayers of Kenergy Corporation (“Kenergy”). Kenergy is part owner of Big Rivers Electric (“Big Rivers”) and purchases generation and transmission service from Big Rivers.
2. The matters being decided by the Commission in this case may have a significant impact on the long term availability and adequate supply of electric power to Alcan/Century from Kentucky generation and therefore the cost of such power. Electricity represents a significant cost of doing business for Alcan/Century and is critical to the continued economic viability of their operations. 
