#### <u>ORDER</u>

On October 11, 1993, in Case No. 93-111, the Commission approved rates for Belfry Gas Company, Inc. ("Belfry") and provided for their further adjustment in accordance with Belfry's gas cost adjustment ("GCA") clause.<sup>1</sup>

On May 30, 2007, Belfry filed its GCA to be effective July 1, 2007.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Belfry's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.

2. Belfry's notice sets out an expected gas cost ("EGC") of \$9.5040 per Mcf. Belfry incorrectly used its purchase volume rather than its sales volume in calculating the EGC. Correcting for this produces an EGC of \$9.6174 per Mcf, which is an increase of 95.45 cents per Mcf from its prior EGC of \$8.6629.

3. Belfry's notice sets out no refund adjustment ("RA"). Belfry's notice sets out no total RA, which is no change from the prior total RA.

4. Belfry's notice sets out a current quarter actual adjustment ("AA") of (17.43) cents per Mcf. Belfry's total AA is (10.92) cents per Mcf, which is a decrease of 16.01 cents from its previous total AA.

5. Belfry's notice sets out no balance adjustment.

6. Belfry's GCA is \$9.5082 per Mcf, which is an increase of 79.44 cents per Mcf from its previous rate of \$8.7138.

7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Belfry on and after July 1, 2007.

IT IS THEREFORE ORDERED that:

1. Belfry's proposed rates are denied.

2. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after July 1, 2007.

3. Within 20 days of the date of this Order, Belfry shall file with the Commission its revised tariff sheets setting out the rates authorized herein.
