ATTORNEY GENERAL'S NOTICE OF NO OBJECTION

Comes now the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention, and files this notice of no objection to the above captioned companies' request pursuant to KRS 278.512(2) for a waiver of any applicable anti-slamming and anti-cramming regulations, including those set forth in KRS 278.535(2). The Attorney General notes the unusual circumstances at hand involving the partial discontinuance of local residential service. In order to ensure that customers continue to receive dial tone, which can be crucial for health and safety, the consumers interests are likely best preserved by granting the request. The Attorney General also makes the observation that the customers will have the opportunity to secure service through other carriers or that the customers can remain with the above companies, without financial penalty under either option.

Accordingly, the Attorney General states that while he has not requested intervention in the case, he was served with a copy of the companies' request for waiver and has no objection to the request.
