NOTICE OF PURCHASED GAS ADJUSTMENT FILING OF DELTA NATURAL GAS COMPANY, INC.

CASE NO. 2007-00244

ORDER

On November 10, 2004, in Case No. 2004-00067,¹ the Commission approved rates for Delta Natural Gas Company, Inc. ("Delta") and provided for their further adjustment in accordance with Delta's gas cost adjustment ("GCA") clause.

On June 19, 2007, Delta filed its proposed GCA to be effective July 24, 2007.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Delta's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.

2. Delta's expected gas cost ("EGC") is \$9.6914 per Mcf, which is 54.37 cents per Mcf more than the previous EGC of \$9.1477.

3. Delta's notice sets out no current quarter refund adjustment ("RA"). Delta's notice sets out no total RA, which, because of the effect of the rolling averages, results in .03 cent more than the previous total RA.

4. Delta's notice sets out a current quarter actual adjustment ("AA") of (44.66) cents per Mcf. Delta's total AA is \$1.01 per Mcf, which is an increase of \$1.7184 per Mcf from the previous total AA.

5. Delta's notice sets out a balance adjustment ("BA") of \$1.4157 per Mcf, which represents a decrease of 56.53 cents per Mcf from the previous BA.

6. Delta's GCA is \$12.1171 per Mcf, which is \$1.6971 per Mcf more than the previous GCA of \$10.42.

7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Delta on and after July 24, 2007.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are approved for final meter readings on and after July 24, 2007.

2. Within 20 days of the date of this Order, Delta shall file with this Commission its revised tariffs setting out the rates authorized herein.
