#### ORDER

On June 22, 2007, South Woodford Water District ("South Woodford") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. KRS 278.012 and 807 KAR 5:068.

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. South Woodford purchases water from the city of Versailles ("Versailles").
- 2. Versailles notified South Woodford that, effective with its July 1, 2007 billing, Versailles' wholesale water rate to South Woodford would increase and its rate design would be changed. Versailles' rate design would change from a four-step declining block design to a flat rate of \$2.20 per 1,000 gallons. South Woodford proposes to increase the water rates to its customers effective July 1, 2007.
- 3. During the 12 months ending May 31, 2007, South Woodford purchased a total of 193,177,000 gallons of water and sold 119,442,100 gallons. The increase in the cost of purchased water is \$35,590.60, resulting in a purchased water adjustment of \$0.30 per 1,000 gallons.

4. The purchased water adjustment of \$0.30 per 1,000 gallons is fair, just, and reasonable and should be approved.

#### IT IS THEREFORE ORDERED that:

- 1. South Woodford's proposed rates are approved.
- 2. The purchased water adjustment of \$0.30 per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after July 1, 2007.
- 3. Within 20 days of the date of this Order, South Woodford shall file with the Commission revised tariff sheets showing the rates approved herein.
