

MEETING CALLED TO ORDER BY WALTER BURKHART

MINUTES OF MAY 2007 MEETING REVIEWED BY THE BOARD. MOTION MADE BY HAROLD SELLERS, SECONDED BY GEORGE HENSLEY, TO APPROVE MINUTES AS READ. VOTE: LANA PACE – YEA; WALTER BURKHART – YEA.

INVOICES REVIEWED BY BOARD. MOTION MADE BY HAROLD SELLERS, SECONDED BY GEORGE HENSLEY, TO PAY ALL BILLS SUBMITTED. VOTE: LANA PACE – YEA; WALTER BURKHART – YEA.

KY REPRESENTATIVE RICK NELSON SUGGESTED THAT WE WRITE A LETTER IN JAN. 2008 TO JUDGE GRIESHOP REQUESTING MONIES FOR A REHAB PROJECT FOR OUR WATER SYSTEM FROM THE JULY 2008 STATE BUDGET OUT OF COAL SEVERANCE FUNDS. SOME DISCUSSION HELD REGARDING THE NECESSITY OF REPAIRING OR REPLACING THE TELEMETRY SYSTEM.

MS. PACE REPORTED TO THE BOARD THAT SHE HAD RENEWED THE NEW HEALTH INSURANCE PLAN WITH BLUE CROSS AT A SAVINGS OF APPOXIMATELY \$500.00 PER MONTH.

RATE I NCREASE FROM PINEVILLE UTILITY DISCUSSED. MS. PACE REPORTED THAT PUBLIC SERVICE HAD TOLD HER THE PROPOSED INCREASES BY PINEVILLE OVER THE NEXT 3 YEARS HAD BEEN APPROVED AS SUBMITTED. THEY DID NOT HAVE TO RESUBMIT FOR EACH NEW INCREASE, BUT THAT WE WOULD HAVE TO RESUBMIT EACH TIME THAT THE RATE WAS INCREASED TO US. THE DIFFERENCE BEING PINEVILLE HAD PROVEN THE ENTIRE AMOUNT COULD HAVE BEEN EFFECTIVE IN JUNE OF 2007 BUT THEY HAD DELAYED THE INCREASES, WHEREAS OUR INCREASES WOULD NOT BE INCURRED UNTIL
