On August 16, 2007, the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention, ("AG") filed a motion requesting an extension of time up to and including August 24, 2007, within which to file his initial data request to Louisville Gas and Electric Company and Kentucky Utilities Company. The AG stated that the extension is necessary because he did not receive a copy of the procedural schedule until August 13, 2007, which did not provide sufficient time for his office to prepare the data request due on August 15, 2007.

Finding good cause to grant the AG's motion, the Commission hereby amends the procedural schedule as set out in our Order of August 8, 2007. A revised procedural schedule is set forth in Appendix A, which is attached hereto and incorporated herein.

IT IS THEREFORE ORDERED that:

1. The AG's request to extend the filing date for responses to data requests originally due on August 8, 2007 to August 24, 2007 is granted.


