Comes the Kentucky Association for Community Action, Inc. ("KACA"), by and through counsel, and hereby objects to the intervention as a full party by Robert L. Madison. In support of this motion, KACA states that Mr. Madison's interests in this proceeding, if any, are fully and adequately represented by the Kentucky Attorney General, who has been granted full intervention by the Commission.

The intervention by Mr. Madison is not likely to raise new and independent matters to which the Commission should be directed and which may be helpful to the Commission. On the contrary, the intervention by Mr. Madison is likely to cause the parties and the Commission considerable undue delay in this time-sensitive matter. This is well illustrated by the numerous data requests served by Mr. Madison before he has been granted the right to intervene as a full party, and directed to organizations other than the Company, which has not been authorized by prior Orders of the Commission.
