<u>ORDER</u>

On August 6, 2007, Apache Gas Transmission Company, Inc. ("Apache Gas") submitted an application requesting an increase in rates pursuant to 807 KAR 5:076, the Commission's Alternative Rate Filing procedure for small utilities. After its filing deficiencies were cured, the application was deemed filed as of August 29, 2007. In order to allow for an appropriate review of Apache Gas's requested rate increase, the Commission finds that a procedural schedule should be established. The procedural schedule established herein may be modified or supplemented at a later date.

IT IS THEREFORE ORDERED that:

1. The procedural schedule in Appendix A to this Order shall be followed in this proceeding.

a. Responses to requests for information shall be appropriately bound, tabbed and indexed and shall include the name of the witness responsible for responding to the questions related to the information provided, with copies to all parties of record and 6 copies to the Commission.

b. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a

governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

c. Any party shall make timely amendment to any prior responses if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect.

d. For any requests to which a party fails or refuses to furnish all or part of the requested information, that party shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.
