To the COMMISSION:

The North Shelby Water Company respectfully requests that the COMMISSION allow us to make an adjustment in our rates in accordance with 807 KAR 5:067 Purchased Water Adjustment clause.

The Company has been told by its suppliers, Louisville Water Company and Shelbyville Municipal Utilities that a \$0.15 and a \$0.05 increase will take effect on September 1, 2007. The Company purchased 259,253,100 gallons from Louisville and 48,715,600 gallons from Shelbyville between July 2006 and July 2007. The result of these increases is an increase to our rates of \$0.10 per 1,000 gallons. We propose to raise each gallonage block that amount.

Dear Mr. Broughman:

On behalf of Louisville Water Company, thank you for attending the meeting of our wholesale customers last week. I appreciate the opportunity for feedback from this important customer group of our Company. Please find enclosed a copy of Bob Miller's comments, our 2006 Rate Study for FY 2007, and a copy of *Principles of Water Rates*, *Fees, and Charges*.

As indicated in paragraph 6.03 of the rate schedule, the rate for wholesale water service on and after May 1, 2007 will be \$1.44 per thousand gallons, plus an elevated service area surcharge of \$0.27 per thousand gallons. This new rate is subject to approval by the Public Service Commission. We are planning to file the necessary documentation for this new rate with the PSC in early March.

I again offer any assistance you may need, as we continue to bring the wholesale rates in line with our cost of service. Patti Kaelin will be following up with you during the next several weeks. The Shelbyville Municipal Water & Sewer Commission ("SMW&SC") has filed a proposed rate schedule which will increase the rate for water service as follows:

The proposed effective date is with the September 1, 2007 billing, which will be for water purchased between July 19, 2007 and August 19, 2007, and thereafter, until the next rate change occurs.
