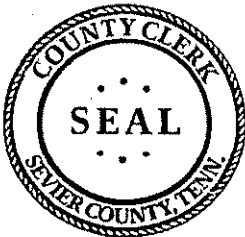

To Whom It May Concern:

KRS 74.020 paragraph (1) subsection (a) states: Members of the board shall be residents of the district, or of any incorporated or unincorporated areas served by the district in the county in which the district was originally established. I live within the city of Salyersville in which the Magoffin County Water District has customers within the city of Salyersville. It is my understanding of KRS 74.020 that I can legally serve as a commissioner for the Magoffin County Water District.


Furthermore the Magoffin County Water District by laws does not address the eligibility of a commissioner. Also if Mr. Conley would have done additional research and read KRS 74.020 cross references paragraph (4) Residence OAG 84-228 it states: A water district board member is not required by statute to be a customer of the water district. A water district by-law requiring such member to be a customer of the water district is in conflict with KRS 74.020.

It is also noteworthy to mention that Mr. Joe Conley a former Magoffin County Water Board Commissioner served over three years with another commissioner who lives within the city of Salyersville. I have been unable to find any official or formal complaint that Mr. Conley ever made as to the eligibility of that particular commissioner.

WHEREFORE, the answering Defendant prays that the complaint be dismissed, that the complaint's relief sought be denied and he take nothing thereby.
