COMMISSION STAFF'S SECOND DATA REQUEST
TO MAGOFFIN COUNTY WATER DISTRICT

Magoffin County Water District ("Magoffin District"), pursuant to 807 KAR 5:001, is to file with the Commission the original and 6 copies of the following information, with a copy to all parties of record. The information requested herein is due on or before December 28, 2007. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Magoffin District shall make timely amendments to any prior responses if either obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any requests to which Magoffin District fails or refuses to furnish all or part of the requested information, Magoffin District shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations.

1. Refer to Magoffin District's response to Commission Staff's First Data Request, Item 9. For each Magoffin District customer who lives within the city of Salyersville, provide the customer's address.

2. Refer to Magoffin District's response to Commission Staff's First Data Request, Item 10. Provide a copy of all ordinances, resolutions, or orders of the Salyersville City Council or other appropriate body that establish Salyersville's boundaries.

3. Refer to Magoffin District's response to Commission Staff's First Data Request, Item 11. Provide a copy of all ordinances, resolutions, or orders of the Salyersville City Council, Salyersville Water Works, or other appropriate body that delineate the Salyersville Water Works service area.

4. Refer to Appendix A of this request.


a. State whether the document at Appendix A is a true copy of an order of the Magoffin County Court.


