On December 22, 2005, in Case No. 2005-00042,¹ the Commission approved rates for Duke Energy Kentucky ("Duke") and provided for their further adjustment in accordance with Duke's Gas Cost Adjustment ("GCA") clause.

On September 7, 2007, Duke filed its GCA to be effective September 28, 2007.

Duke previously obtained Commission approval to file its GCA within 20 days of the proposed effective date.²

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Duke's notice includes rates designed to pass on to its customers its expected change in wholesale gas costs.

2. Duke's Expected Gas Cost ("EGC") is \$7.492 per Mcf, which is a decrease of 52.6 cents per Mcf from its previous EGC of \$8.018.

3. Duke's notice sets out no current quarter Refund Adjustment ("RA"). Duke's notice sets out a total RA of 0 cent per Mcf, which is no change from its previous total RA.

4. Duke's notice sets out no current quarter Actual Adjustment ("AA"). Duke's notice sets out a total AA of 37.4 cents per Mcf, which is no change from its previous total AA.

5. Duke's notice sets out a current quarter Balance Adjustment ("BA") of (.3) cent per Mcf. Duke's notice sets out a total BA of 2.4 cents per Mcf, which is no change from its previous total BA.

6. Duke's Gas Cost Recovery Rate ("GCR") is \$7.89 per Mcf, which is a decrease of 52.6 cents per Mcf from its previous GCR of \$8.416.

7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Duke on and after September 28, 2007.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are approved for final meter readings on and after September 28, 2007.

2. Within 20 days from the date of this Order, Duke shall file with the Commission its revised tariffs setting out the rates authorized herein.
