

### TERMS AND CONDITIONS OF PAY-AS-YOU-GO CELLULAR SERVICE

(1) PARTIES. This Agreement is made by the individual or organization ("Customer") identified above and Bluegrass Cellular Inc. ("Bluegrass Cellular") as an agent for the cellular network operator ("licensee") licensed by the Federal Communications Commission to serve Customer's primary service area. Depending on Customer's primary service area, the Parties to this Agreement are the Customer and Kentucky RSA #3 Cellular General Partnership (d/b/a Bluegrass Cellular). Kentucky RSA #4 Cellular General Partnership (d/b/a Bluegrass Cellular). Cumberland Cellular Partnership (d/b/a Bluegrass Cellular) or Bluegrass Cellular) or Bluegrass Cellular) or Bluegrass Cellular) or but the cellular partnership (d/b/a Bluegrass Cellular). Bluegrass Cellular may be contacted at PO Box 5012. Elizabethtown, KY 42702 or by telephone at 270-769-0339 or 800-928-2355

(2) SERVICE. Bluegrass Cellular will provide Customer access to cellular telephone and related services, on a pay-as-you-go basis only within the area effectively served by the licensee. The area effectively served is subject to transmission limitations caused by atmospheric and natural or artificial conditions generally beyond the control of Bluegrass Cellular, including the type and condition of Customer's cellular equipment. Services are furnished subject to the condition that there will be no abuse or fraudulent use thereof. Any attempt to abuse or to fraudulently use services by Customer may result in the immediate suspension or cancellation of service. Cellular services do not include use of 1-900 numbers, international or credit card calls

(3) ACCESS: System access will be provided by means of a ten (10) digit telephone number. Bluegrass Cellular and the network service provider reserve the right to change any or all such numbers on not less than the (10) days notice. Customer has no property right whatsoever in the telephone number

(4) CONDITIONS OF SERVICE. (a) Pay-As-You-Go cellular telephone service requires the prepayment of the applicable activation fee of \$15.00. (b) Customer may use Customer's Bluegrass Cellular pay-as-you-go cellular telephone service only so long as Customer's pay-as-you-go account has a cash balance (c) Customer's pay-as-you-go cellular PIN is valid for only sixtly (60) days atter the dollar amount of the pay-as-you-go cellular PIN is valid for only sixtly (60) customer s account at Bluegrass Cellular ANY MONETARY BALANCE REMAINING ON THE ELECTRONIC RECORD OF THE CUSTOMER'S ACCOUNT, 60 DAYS AFTER ENTRY OF THE PAY-AS-YOU-GO CELLULAR PIN NUMBER WILL BE REMOVED FROM CUSTOMER'S ACCOUNT AND CREDITED TO THE ACCOUNT OF BLUEGRASS CELLULAR SUCH THAT THERE IS. IN EFFECT. A MINIMUM MONTHLY CHARGE (d) If Customer's pay-as-you-go cellular telephone number may be required and new activation fees shall be required to re-establish service and new cellular telephone number may be required (e) Any other provision hereof to the contrary notwithstanding. *Customer's* pay-as-you-go cellular PIN shall have no monetary value whatsoever after the date pre-printed on the PIN receipt (f) Customer's pay-as-you-go cellular PIN is just like cash; and, as such, it is not replaceable, refundable exchangeable or rechargeable by Bluegrass Cellular.

(5) BLUEGRASS UNLIMITED PAY-AS-YOU-GO PLAN. Customers contracting for BLUEGRASS UNLIMITED PAY-AS-YOU-GO plan have special restrictions on their calling privileges. Specifically, Customers of the BLUEGRASS UNLIMITED PAY-AS-YOU-GO plan may not place and/or receive calls that would incur long distance charges. If Customer wishes to place such a call, Customer must use a valid caling card or other PIN roaming/long distance solution. In addition, Customer may not place or receive roaming calls, unless otherwise noted in the "Comments" field of this agreement. Customers of this plan may, however place and/or receive an unlimited amount of local calling area calls. Local calling area calls are not subject to additional charges beyond the payas-you-go charge assessed by Bluegrass Cellular to establish or maintain Customer's cellular telephone service. At no time is BLUEGRASS UNLIMITED PAY-AS-YOU-GO service refrundable. Terms and conditions (4)(b)-(c) and (4)(e)-(1) of this agreement do not apply to Customers contracting for BLUEGRASS UNLIMITED PAY-AS-YOU-GO PLAN.

(6) LIMITATION OF LIABILITY. Bluegrass Cellular shall not be liable to Customer for any interruptions of service whatsoever caused by failure of equipment or services not provided by Bluegrass Cellular. Itailure of communications, power outages, or other interruption not within the complete control of Bluegrass Cellular, nor shall Bluegrass Cellular be liable for performance deficiencies caused by Customer's equipment. Bluegrass Cellular's performance under this agreement shall be excused by labor difficulties, governmental orders, civil commotions, acts of God, or other conditions or circumstances beyond its reasonable control Bluegrass Cellular shall not be liable to Customer's equipment render the same obsolete or otherwise alfect its performance. There shall be no credits, reductions, or setoff against the charges for service for downtime or interruption of service for each twenty-four (24) hour period from the time of notice of interruption until service restoration provided Customer notifies Bluegrass Cellular shall not be liable for any incidental, consequential or punitive damages including but not limited to toss of profits, loss of business or business on pusices approximity or loss of use. BLUEGRASS CELLULAR MAKES NO WARRANTIES OR REPRESENTATIONS, EITHER EXPRESS OR IMPLIED, CONCERNING ITS SERVICES AND EXPRESSLY DISCLAIMS WARRANTIES OF FITNESS FOR A PARTICULAR USE OR PLIPPOSE, THE WARRANTY OF MERCHANTABILITY OR ANY OTHER WARRANTY IMPLIED BY LAW

(7) REGULATION This agreement shall at all times be subject to change or modification required by the regulatory authority of the state in which service is provided, the Federal Communications Commission or any other authorized governmental body

(8) NON-WAIVER: Failure of either party to this agreement to enforce any right shall not constitute a waiver of such right or of any other right, whether of a similar or dissimilar nature, and shall not prohibit the exercise of the same right at a future date

(9) CONTROLLING DOCUMENT: THE TERMS AND CONDITIONS SET FORTH IN THIS AGREEMENT SUPERSEDE ANY OTHERS, INCLUDING PRIOR OR CONTEMPORANEOUS REPRESENTATIONS OF SALES REPRESENTATIVES OR THE PERSONNEL OF BLUEGRASS CELLULAR WHETHER ORAL OR WRITTEN

(10) EQUIPMENT INSURANCE: If you subscribe to Signal Dial Direct Plus insurance, you acknowledge that the equipment identified in this Agreement is in your possession and in good working order, and that you have received, read and understood the terms and conditions under which that insurance is offered. Accessory coverage can only be purchased in conjunction with equipment coverage. Customer acknowledges that this insurance protection is offered by The Signal. that Bluegrass Cellular acts s a billing agent for The Signal and that any claims regarding this insurance or its administration shall be directed to The Signal at 1-888-352-9183.

(11) DISPUTE RESOLUTION: Any dispute or controversy arising out of or relating to this agreement, the interpretation of this agreement, or any matter within the exclusive or original jurisdiction of the Public Service Commission of the Commonwealth of Kentucky, including matters arising under KRS 278 260, shall be settled exclusively and finally by arbitration between Bluegrass Cellular and customer. The arbitration shall be conducted in accordance with the wireless industry arbitration rules established by the American Arbitration Association. as may be amended by Bluegrass Cellular. The arbitration shall be conducted before a sole arbitrator, and under no circumstance shall punitive damages be awarded in the arbitration. Any award rendered in such arbitration proceedings shall be final and binding on each of the parties, and judgment may be entered thereon in a court of competent jurisdiction.






