RE: Informal Conference of January 29, 2008

On January 29, 2008, representatives of Gasco Distribution Systems, Inc. ("Gasco"), the Office of the Attorney General ("AG") and Commission Staff ("Staff") met at the Commission's offices to discuss Gasco's gas cost adjustment ("GCA") filing dated September 26, 2007. A list of attendees is attached to this memorandum.

Gasco spent a few moments describing the makeup of its current system, the need for Gasco to reinstate itself with the Secretary of State, and the need for Gasco to recover, in some fashion acceptable to all parties, the under-recovered gas costs proposed in its GCA filing.

The remainder of the discussion centered on the interpretation of KRS 278.225, Time Limitation on Billing-Liability for Unbilled Service. The AG and Gasco disagreed on the applicability of the statute to Gasco's situation and agreed to further review the information and see if a negotiated resolution of the case might be possible.
