

Grayson Rural Electric is amending its original application to include the following information.

- Pursuant to 807 KAR 5:001 Section 8(3), Grayson's Articles of Incorporation and all amendments have been previously filed in case no. 92-496.
- Pursuant to 807 KAR 5:001 Section 9(2)(a), the proposed construction and remodeling is necessary to:
 - Providing convenience to members through the use of a drive up facility.
 - Providing security for its employees and assets.
 - Providing additional space to serve a growing membership and accommodate a changing work environment.
 - Update elements of building and fire codes.
- Pursuant to 807 KAR 5:001 Section 9(2)(b), permits that will be obtained prior to construction are a Grayson city building permit and Kentucky State Department of Housing, Buildings and Construction permits.

- Pursuant to 807 KAR 5:001 Section 9(2)(c), Phase 1 will consist of building and modifying walls in existing areas. It will also consist of constructing a remote drive up kiosk with an underground tube system connected to the interior of the building. Also included in this phase, an existing room will be converted to a customer service center. We are requesting the authority to proceed with this phase immediately.


Phase 2 will consist of tearing off a 11' x 76' portion of the back of the building (originally a porch) and building a 22' x 76' addition that is wood frame construction with a wood exterior finish. We are anticipating starting this construction in the Spring of 2008.

There are no persons, public utilities, corporations with which this proposed new construction is likely to compete.

- Pursuant to 807 KAR 5:001 Section 9(2)(f), the estimated cost of this project is as follows:
 - Phase 1 - \$180,000
 - Phase 2 - \$508,000

Total - \$688,000

Bids for construction by interested firms have not been requested as of this date.
