ORDER

On April 16, 2008, the applicant, Farmdale Development Corporation ("Farmdale"), moved to have a formal hearing in this matter. On February 11, 2008, the Commission, by Order, published the report by Commission Staff which outlined adjustments and recommendations to Farmdale's proposed rates and revenue requirements based on an evaluation of the operating revenues and expenses for the test period. On February 22, 2008, Farmdale submitted its response to the report by Commission Staff, in which it objected to most of the recommendations contained therein. Those objections were reiterated within Farmdale's motion for a formal hearing.

The Commission finds that Farmdale's motion for a formal hearing should be granted. The Commission shall establish a procedural schedule, attached hereto as Appendix A. All witness summaries shall be sworn and shall include details on the professional background of the witness and the scope of the witness's professional relationship to the sponsoring party. Modifications to this schedule may occur but only upon Order by the Commission.


IT IS HEREBY ORDERED that:

3. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.
4. All documents that this Order requires to be filed with the Commission shall be served upon all other parties.
5. Service of any document or pleading shall be made in accordance with Administrative Regulation 807 KAR 5:001, Section 3(7), and Kentucky Civil Rule 5.02.
6. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
