2. Individuals granted full intervention shall be entitled to the full rights of parties and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.

3. Individuals granted limited intervention shall be entitled to the full rights of a party at any hearing. Limited intervenors shall be served with the Commission's

Orders, but shall not be served with filed testimony, exhibits, pleadings, and all other documents submitted by parties and shall not be certified as parties for the purpose of receiving service of any petitions for rehearing or petition for judicial review.

4. Should any intervenors, both full or limited, file documents of any kind with the Commission in the course of these proceedings, they shall also serve a copy of said documents on all other parties of record.
